
SUMMARY

In the 12 months to March 2024:

- The value of South Australia's overseas goods exports totalled \$17.7 billion, up 2.8% (\$489 million) on the previous twelve months (moving annual total, in original terms).
- Nationally, the value of overseas goods exports totalled \$545.4 billion, down 10% (\$62.5 billion) over the same period.
- South Australia accounted for 3.3% of national overseas goods exports value.
- An increase in overseas goods exports in the year to March 2024 was only recorded for South Australia (up 2.8%), while decreases were recorded for Victoria (down 2.6%), Tasmania (down 4.3%), Western Australia (down 5.5%), the Northern Territory (down 13%), Queensland (down 15%) and New South Wales (down 23%). MAJOR EXPORT DESTINATIONS

Major South Australian export markets that experienced growth in the year to March 2024 compared with the year to March 2023 included:

- China (up \$1.0 billion or 39%);
- United States of America (up \$360 million or 23%);
- Thailand (up \$224 million or 30%);
- Indonesia (up \$208 million or 31%); and
- Pakistan (up \$141 million or 212%).


(Annual growth in exports of more than \$100 million was recorded for 9 export destinations).

Major South Australian export markets that experienced a decline in the year to March 2024 included:

- Philippines (down \$461 million or 42%);
- Canada (down \$387 million or 53%);
- Bangladesh (down \$267 million or 55%); and
- Saudi Arabia (down \$230 million or 68%).
- Belgium (down \$152 million or 81%).

MAJOR EXPORT COMMODITIES


In South Australia, export commodities recording growth in the year to March 2024 compared with the year to March 2023 included:

- Petroleum and petroleum products (up \$302 million or 170%);
- Barley (up \$240 million or 36%);
- Vegetables (up \$171 million or 15%);
- Machinery and transport equipment (up \$141 million or 27%); and
- Iron ore and concentrates (up \$127 million or 12%).

During the same period, South Australian exports that recorded a decline in value included:


- Wheat (down \$310 million or 12%);
- Meat of sheep and goat (down \$90 million or 14%);
- Wine (down \$56 million or 4.2%);
- Wool and animal hair (down \$50 million or 28%).
- Oil-seeds and oleaginous fruits (down \$32 million or 5.4%); and

Notes: Monthly estimates of merchandise exports are generally volatile and are unadjusted for seasonal factors—consequently monthly data should be treated with caution. Figures in this brief are reported in moving annual total terms to remove the impact of seasonality.

All data is in original nominal terms, hence both quantity and price changes contribute to changes in values.
